DIRECTIONS FOR USE

Add FIRST AMINO 6-2-3 to the spray tank when half full. Agitation in the tank will enhance the speed of solubility. FIRST AMINO 6-2-3 is compatible with most pesticides and fertilizers. However, a compatibility test is recommended if the desired combination has not been used in the past.

RECOMMENDED RATES

The optimum rate and timing of application will depend on local conditions and should always be made as a result of soil and/or plant tissue analysis in consultation with your local turf/ornamental authorities. In the absence of test results use the following as a guide. Use the following rates with sufficient water for thorough coverage.

Cool Season Grasses.....	4-12oz/1000 sq ft with 1-2 gallons water
Warm Season Grasses.....	2-6oz/1000 sq ft with 1-2 gallons water
