DIRECTIONS FOR USE

Shake well before each use. First-4-0-8 may be tank mixed with most liquid fertilizers and pesticides; however, a jar compatibility test should be performed for unknown combinations. Apply in sufficient water to ensure thorough coverage. Irrigate within 18 hours after application. Apply fertilizer in accordance with best management practices established by your State University or Cooperative Extension Service. Observe all state and local fertilizer regulations pertaining to fertilizer content, application rates, and timing specific to your area.

RECOMMENDED RATES

Greens: Apply First-4-0-8 at 2–6 oz per 1,000 sq ft.

Fairways & Tees: Apply First-4-0-8 at 2–4 oz per 1,000 sq ft, either alone or tank mixed with foliar nutrition, fungicide, or herbicide products. Apply with sufficient water to ensure adequate coverage.
