DIRECTIONS FOR USE

For best results, begin with a freshly cleaned foam tank. Foam generation can be affected by scale, rust or other solid materials in the tank. Mix First-Foam Marker with water and place in foam marker tank. Use as a visual marking aid in foam marker systems to indicate application coverage

RECOMMENDED RATES

Use 1 gallon of First-Foam Marker for every 100 gallons of water. First-Foam Marker is formulated to be used at a 100:1 ratio. Overdosing and underdosing can lead to poor-quality foam, but the rate may be carefully adjusted. If the foam is runny or watery, add additional First-Foam Marker until the preferred texture and stability are achieved. If the foam is too thick, add water.
