First-Pigment Remover is a concentrated, dual-purpose cleaning agent. Apply directly to tough stains as a ready-to-use (RTU) solution, or dilute for daily maintenance of tank pigment, dye, and oil stains, as well as other hard-to-remove residues. It is suitable for most surfaces that come into contact with spray equipment.

DIRECTIONS FOR USE

First-Pigment Remover is highly concentrated and may be applied directly to tough stains as an RTU solution. Apply as a mist and allow it to soak for 1–2 minutes, then scrub and rinse. If stains remain, reapply and repeat the process. For normal (external) tank stain removal, dilute 1:1 (50/50) with water. Apply, allow to soak for 1–2 minutes, then scrub and rinse. Removes pigment and other stains quickly.

For internal tank cleaning of pigment, spray dye, and stain removal: add 2 quarts per 100 gallons of water. Circulate for 10 minutes, then clean and rinse. First-Pigment Remover is safe for rinsate disposal. Always follow local and state guidelines for proper disposal of rinsates.
