DIRECTIONS FOR USE

First-Iron6 is amine compatible and can be applied with most pesticides and other foliar nutrients. Always check compatibility before mixing. This product may applied by ground application. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant. Follow the mixing sequence: 1. Water; 2. First-Iron6 liquid iron; 3. Pesticide

RECOMMENDED RATES

The optimum rate and timing of application will depend on local conditions and should always be made as a result of soil and/or plant tissue analysis in consultation with your local turf/ornamental authorities. In the absence of test results use the following as a guide. Use the following rates with sufficient water for thorough coverage.

Cool Season Grasses.....	2-6oz/1000 sq ft with 1-2 gallons water
Warm Season Grasses.....	2-6oz/1000 sq ft with 1-2 gallons water
