DIRECTIONS FOR USE

First Poly can be soil or foliar applied through ground applications. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For foliar applications, dilution rates should be at least one part First Poly to 20 parts water solution. First Poly will disperse in water with minimal agitation. Always check compatibility before mixing. Follow the mixing sequence: 1. Water; 2. First Poly; 3. Pesticide. Do not apply to foliage of any crop when temperatures are above 90°F. Apply First Poly early morning or late evening. This product is only intended for use during the establishment or repair of turf or when a soil test indicates a phosphorous deficiency.

RECOMMENDED RATES

The optimum rate and timing of application will depend on local conditions and should always be made as a result of soil and/or plant tissue analysis in consultation with your local turf/ornamental authorities. In the absence of test results use the following as a guide. Use the following rates with sufficient water for thorough coverage.

Cool Season Grasses	4-8oz/1000 sq ft with 1-2 gallons water
Warm Season Grasses	2-6oz/1000 sq ft with 1-2 gallons water
